Dear Sir,

The erstwhile GEB had approved the ex-gratia payment in case of accident occurred in animal lives vide circular No. OM/CR- I/ACCIDENT/8644 Dtd. 24.07.1997, which is in existence as of now.

Many representations were received through the Government that the present rates of ex-gratia payment approved and paid in case of accident to animal lives are very less and it should be enhanced. Accordingly the GUVNL Board of Directors vide resolution No. 53.14/890 have approved to revise the rates of Ex-gratia payment in case of accident involving animal lives as under:
