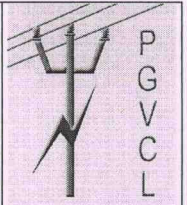

AMENDMENT TO CIRCULAR No.922 dated 15.4.2013

Sub: **Revision of rate of ex- gratia payment in case of accident involving animal lives.**

Ref: (1) Circular No. OM/CR- I/ACCIDENT/8644 dated 24.07.1997
 (2) Circular No.GUVNL/Tech/Accident/922 dated 15.4.2013

Vide Circular No.922 dated 15th April, 2013, approval of the Board of Directors of GUVNL, enhancing the amount of ex-gratia payment in case of accident to animal lives, was conveyed. Subsequently, in view of the feedback received from the field, it was proposed to slightly enhance the compensation amount in respect of Sr. No.(5) of above Circular (i.e. She Buffalo – above 2 years) to Rs.20,000/- in place of Rs.15,000/-. Accordingly, the Board of Directors of GUVNL, vide Resolution No.54.02/896 dated 17.4.2013, have approved the proposal. Therefore, Sr. No.(5) of Circular No.922 dated 15.4.2013, stands modified as under:

5	She buffalo	Above 2 years	20000/-
		Up to 2 year	5000/-

Other contents of Circular No.922 dated 15.4.2013 remain un-changed.

A copy of the aforesaid GUVNL Board resolution is forwarded here with to take necessary action to uniformly implement the decision taken by the Board of Directors of GUVNL.

The above revised rate of Ex-gratia payment will come in to force from the date of Board resolution i.e. 17.4.2013.

All field officers are directed to make Ex-gratia - payment within time limit - after following due process.
