GENERAL CONDITIONS

1. EARNEST MONEY DEPOSIT:

- a) Earnest money deposit as indicated on the face sheet should be paid by the tenderer along with the tender in by DD only of any schedule Bank in favor of Paschim Gujarat Vij Co. Ltd., Amreli.
- b) Tender without earnest money are not liable to be considered.
- c) Earnest money deposit will be forfeited in case the successful tenderer after his tender has been accepted shall refuse to pay the prescribed Security Deposit and execute the Contract Agreement.

2. VALIDITY OF TENDERS: All tenders shall be opened for acceptance by the Company for a period of **180 days** from the date of opening the tenders and may be further extended to 30 days if required and the tenderer shall be bound to execute the work on such acceptance.

3. ACCEPTANCE OF TENDER: The Company does not bind itself to accept the lowest or any tender neither will any reason be assigned for the rejections. It is also not binding on the Company to disclose any analysis reports on the tender.

4. SECURITY DEPOSIT: The tenderer whose tender is accepted shall have to pay security Deposit 5% of the tender cost, in D.D within 7 days from the receipt of the LOI. In case contractor fails to pay up the security Deposit within the specified time, his earnest money will be forfeited without issuing any notice.

5. SOLVENCY CERTIFICATE: The tenderer shall have to produce the solvency certificate from the Collector of District within which he resides or a banker's certificate of his financial stability for the amount as deemed fit by the undersigned.

6. PROVIDENT FUND CODE: The agency should obtain P.F. code number in tenderer's name from the Regional Provident Fund Commissioner. Without P.F. code Number, Tender will not be considered for acceptance. Also you should comply with the provisions of the EPF and MP Act – 1952.

7. PAN CARD NO.: The contractor shall have PAN No. in the name of Tenderer. The contractors. The contractor has to submit attested copy of PAN Card along with tender

8. GST REGISTRATION: The contractor has to submit the attested copy of GST Registration documents in the name of Tenderer. GST will be applicable as per company's rules.

9. EXPERIENCE CERTIFICATE: The tenderer has to submit the attested copy of experience certificate for carting work carried out by him satisfactorily.

10. VEHICLE DOCUMENTS: The tenderer has to submit attested copy of possession of vehicles suitable for carting PSC poles. The Agency has to produce ownership documents along with the tender, failing which the bid is liable to be rejected without assigning any reason.

11. CONTRACT DOCUMENTS: The tenderer whose tender is accepted will have to execute a Stamped agreement in standard form of the Company and will have to sign the Contract Booklet at his own cost. In case of partnership firms, necessary partnership documents will have to be produced for verification of authority to sign the bills measurements and enter into contract as well as correspondence with the Company. Wherever required necessary power of attorney will have to be produced.

12. JURISDICTION: Any dispute or differences arising out of or in connection with the Contract if concluded shall be subject to the exclusive jurisdiction of Amreli.

13. If any injury to labours during loading, un-loading the poles, you will be full responsible for any compensation.

14. Insurance papers of the vehicle and labours should be submitted to Circle office, before starting the work.

15. The tender will be issued to those transport contractors who are in possession of vehicles suitable for carting PSC poles. The Agency have to produce ownership documents along with the tender, failing which the bid is liable to be rejected without assigning any reason.

16. The agency should obtain **P.F. code** number **in tenderer's name** from the Regional Provident Fund Commissioner. Without P.F. code Number, Tender will not be considered for acceptance. Also you should comply with the provisions of the EPF and MP Act – 1952.

17. You should possess the license from the licensing authority under the provisions of contract labour (R&A) Act-1970

18. You should comply with the provisions of payment of minimum wage Act. Payment to the contract labours should be made in presence of Company's authorized representative in conformity with the minimum wages under the Act.

19. Payment of carting will be made on actual carting distance for each pole applicable.

SPECIAL CONDITIONS OF CONTRACT TO CARTING OF PSC POLES FROM POLE FACTORIES

1. The tender pertains to the transportation of PSC poles of 8 meters of the estimated quantity mentioned in Schedule-B for a period of 12 months or the Amount of contracted are fully Completed.

The Company reserves the right to extend or to reduce the contract period of the original order for sixteen weeks and/or to place repeat order with the contract up to 20% of the original quantity of the order on the same rates, terms and conditions as stated in the original order placed by the Company with the contractor during the period, and time limit for carting will be extended prorate.

2. The location to which the poles are to be transported from the pole factories shall be decided by the SE or the EE of the concerned Circle or Division for the locations under their jurisdiction. The maximum delivery locations will be four per trip of 20 poles and the contractor has to unload the poles accordingly.

Any poles carted to the place/location other than the destination specified in the MR such poles shall be re-carted by the contractor to the location/destination specified in the MR in event of failure of the contractor to do so they will be carted either by the Company or through other agency on account and at the risk of the contractor.

3. The rates are being inclusive of loading of poles at the factories, transportation of poles from factory to the destination as directed by the concerned Engineer of the Company and unloading and stacking the same at destination in good condition.

4. Contractors shall be solely responsible for damages if does to the poles during loading, transportation unloading and stacking the poles at site. The cost of damages to the cost of such damages will be fixed by the field officers of the Company in whose jurisdiction the poles are carted. His decision shall be treated as final.

5. The tenure of this contract shall be effective from the date of issue of order or the material requisitions given after the date of issue of this letter to twelve months or the pole contracted are fully transported as per condition No.1 above.

6. The contractor shall have to transport the poles every month as per allotment of poles from the concerned factory. The quantities of poles and the destination to which the poles are to be transported shall be fixed by the Company's Officer from time to time.

7. It must be clearly understood that the estimated quantities of poles indicated above are approximate and that they are likely to be more or less or to be NIL during any month or at any time or the contractual period. The actual quantities to be transported will entirely depend on actual production/requirement of poles by the factory from time to time. If for any reason, the factory is unable to manufacture estimated quantity of poles shown above in any month or at any time of the contractual period the contractor will be entitled to transport the quantities manufactured in any particular month. The Company's officers reserve the right to increase or decrease the quantities of poles to be transported or delete any item either partly or wholly during the contractual period. Payment of such work will be based on the offered rates and measurement for work actually done. No increase in rates will be allowed for such increase or decrease in quantities of work.

8. A) If the contractor fails to transport poles during any month as directed by the Company's officers. The M.R. pending at Pole Factory for more than one week and Company shall transport these poles through any other Agency, or departmentally at the risk and cost of the contractor without

giving any notice or observing any formalities in this regard and in that case any expenses that may be incurred in excess of the sum which would have been paid to the original contractor if the said work had been executed by him shall be borne and paid by the original contractor. The contractor will have no claim for compensation for any loss sustained by him owing to such action.

B) Also the Company reserves the right, to impose penalty at 1/2% of contract value per week subject to a maximum of 10% of the contract value. However, the contractor will be condoned on account of non-availability of PSC poles or due to unforeseen circumstances on his furnishing satisfactory reasons and/or production of documentary proof there of as per rules of Company/DOP of Company.

9. The contractor shall have to enter into an agreement with the Company on stamp paper of appropriate value in the prescribed form whose cost shall be borne by the contractors

10. The General terms and conditions of contract prescribed by Company in booklet shall be binding to the contractor and the contractor shall have to sign the same.

11. The payment shall be made by the EE (O&M) concerned based on the certificate & all relevant records of the Sub-Division Officers for whom the poles are carted.

12. DAMAGE FOR DELAY IN CARTING:

If the contractor fails in the due performance of the contract within the time stipulated by the contractor or any retention thereof the liable to pay at the discretion of the Engineer, penalty up to 1/2% of the contract price per week subject to a maximum 10% reckoned on the contract value of such portion of the poles to be carted.

13. TERMINATION OF CONTRACT.

A) In case the contractor fails to cart the requisite number of PSC poles as allotted from time to time within the specified period of delivery or any retention thereof the Engineer-in-charge shall exercise his discretionary powers either (1) to recover from contractor damages by way of penalty as stated in the Clause 15 above of (2) to entrust the work of carting else-where after giving due notice to the contractor on account and at the risk of the contractor without canceling the contract in respect of the unexecuted work. (3) Or to rescind the contract and carry out the work under condition No.4 of the booklet of 'Tender & Contract for works' and adopt any of the courses under (b) and (c) thereof. **B)** In the event of the Company taking action under Claus 16(a) 2 or 3 stated above the contractor shall be liable for any loss which the Company may sustain on that account but the contractor shall not be entitled to any gain on such account made against his default.

14. The loading and unloading of PSC pole shall be done with two point lifting and single point lifting will not be allowed under any circumstances.

16 Whenever there is a conflict between the aforesaid special conditions of contract booklet, the special conditions will prevail.

17. Company may need huge quantity of poles in very short period in special circumstances then Company reserves the right to cart through other carting contractor without informing the contractor to whom order is placed for particular pole factory.

18. The Company reserves the right to place the work order to two different agencies in respect of tender inquiry.

19. Poles for carting will be available to carting contractor from the pole factory during working hours of pole factory, as directed by Company's in charge Officer.

20. Unless agreement is finalized no R.A. bills payments will be made to the contractor.

21. It will be responsibility of contractor to inform to consignee as soon as the poles are loaded in the truck for transportation to destination so that contractor may have got receipt of poles from concerned consignees early.
22. In case if poles are lifted from pole factory and could not reach at proper destination/ site and found missing then the cost of such poles will be recovered from carting contractor without any further reference.
23. Rate escalation clause due to increase in rates of diesel/ The Company agree to increase/decrease the rates by one paise per pole per KM. For increase/decrease in rates in diesel by Rs.0.50 ps. per liter as the case may be. This increases/decrease in rates will be considered with the base date as Date of Closing of Online Submission.
24. Rate escalation due to increase/decrease in rates of diesel will not be applicable to minimum charges.
25. Conditional tender to be out rightly rejected.
26. The Company reserves the right to place order of 50% of tendered quantity to two different carting Agencies at same rates, terms & conditions.
27. Contractor is required to transport poles of order quantity from any pole factory of Gujarat to **Amreli Circle** to any destination as per allotment. And also vice versa.
27. Recovery of broken poles found at site and if contractor has any claim, the same should be got jointly inspected by concerned EE and his report will be final and binding and accordingly recovery of broken poles as per Company's rates will be made.
28. The contractor will have to cart PSC poles as per monthly allotment given by higher authority strictly for various divisions under Amreli Circle. If the contractor fails to cart the PSC poles as per allotment penalty will be levied for non-carting of poles for a particular division.
29. Tall Tax Will be reimbursed by PGVCL on Production of Proof up to Satisfaction of official of PGVCL; if presented at the time of Passing of bill of Carting of bill of carting of PSC pole.
