Other registration will also be required if taxes are claimed. TDS will be deducted as per rules. The certified copy of PAN and GST in the firm’s name is to be submitted along with tender bid.

Tender fee(Nonrefundable) Rs.1180/- and EMD Rs.500 /- must be paid between 11.00 am to 4.00 pm at PGVCL Corporate Office on working days through Cash / D.D. payable at Rajkot in favour of Paschim Gujarat Vij Company Limited. Copy of receipts of EMD and tender fee payment should be attached with your quotation. The quotation without EMD and tender fee receipt copy and required certificates / documents shall be rejected.

All the relevant documents of quotation should be submitted only by R.P.A.D. / Speed Post addressed to The Chief Engineer (Project), Paschim Gujarat Vij Company Limited., Regd. and Corporate Office, “Paschim Gujarat Vij Seva Sadan”, Laxminagar, Off Nana Mava Road, Rajkot – 360 004 on or before due date. Quotation sent otherwise like through Courier Service or Hand Delivery or any other way will be treated as cancelled.
Party is required to prepare 3 separate sealed covers within main envelope.
 - a) One sealed cover is for EMD and Tender Fee receipt copies with clearly marked “EMD & Tender fee Cover for CCTV AMC-2018” on envelop.
 - b) Other sealed cover is for Price Bid (Rates to quote to Schedule-B) with clearly marked “Price Bid for CCTV AMC-2018” on envelop.
 - c) All other technical and commercial documents to keep in third sealed envelope with clearly marked “Technical Documents for CCTV AMC-2018” on envelop.
8. The bills should be submitted by the contractor in our IT section. While submission of bills, it will required to submit the documents such as copy of call sheet by the contractor.
9. The undersigned reserves the right to accept any or reject any or all offers without assigning any reason thereof and the decision of undersigned in this regard shall be final and binding. Likewise, the undersigned reserves the right to forfeit the Security Deposit and / or cancel

The same will be refundable as soon as maintenance contract is successfully carried out in full as per order and on receipt of "No Objection Certificate" from our I.T. section.
