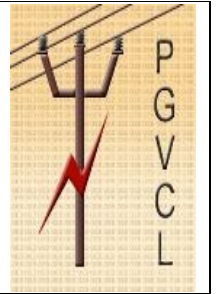

(3) The Price Bid is to be submitted ON LINE only where as Technical Bid is to be submitted in both the forms i.e. On Line as well as Physical.

Note: - Bidders are requested to submit price – bid (Schedule – B) on-line only and not to submit the price bid in physical form. Further if the quantity quoted differs in any of the technical bid forms and in price bid forms, it is discretion of Engineer, PGVCL to consider the quoted quantity.
