6. Bidders willing to participate in tender should have valid digital certificate / Digital Signature as per Information Technology Act 2000 using which they can sign their electronic bids. Bidders can also procure the same from (n) code solutions, a division of GNFC Ltd., who are licensed certifying authority by Govt. of India.
7. For erecting poles, the pits should be digging by using Pole Erection Devise (PED Machine). Where ever it is not possible to use the PED machine in the area lick hard rock, small streets etc. the permission of the engineer in charge shall be obtained for digging of pits as per the conventional method.
